



ARTICLES OF INCORPORATION

OF

CANCER ASSISTANCE FUND FOR SOUTH ALABAMA, INC.

a Florida Not For Profit Corporation

THE UNDERSIGNED, for the purpose of forming a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is CANCER ASSISTANCE FUND FOR SOUTH ALABAMA, INC. The principal place of business is 4415 Devereux Drive Pensacola, Florida 32504. Mailing address is 4415 Devereux Drive Pensacola, Florida 32504.

ARTICLE II
DURATION

The duration of this corporation is perpetual.

ARTICLE III
PURPOSE

The corporation is a not for profit corporation under Chapter 617, Florida Statutes. The corporation is not formed for pecuniary gain or profit, direct or indirect, to itself or its members, directors or officers. No part of the income or assets of the corporation is distributable to or for the benefit of its directors or officers. The corporation is organized, and shall be operated exclusively for charitable purposes to offer hematology and oncology patients with financial assistance and related services for medical care and treatment. The corporation is organized to do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3), of the Internal Revenue Code.

ARTICLE IV

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


