



Article III: Purposes

| A. The said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, |

| for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) |

| permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal |
| Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which |
| are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax |
| code. |
| C. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning |
| of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be |
| distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed |
