ARTICLES OF INCORPORATION**OF****BEACHES GO GREEN, INC.
(A Not-for-Profit)**

Pursuant to Section 617.0202, Florida Statutes, the undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the corporation is Beaches Go Green, Inc., a not-for-profit corporation.

**ARTICLE II
PLACE OF BUSINESS**

The principal place of business and the mailing address of the corporation is 320 1st Street North, Number 701, Jacksonville Beach, FL 32250, or as subsequently changed as deemed appropriate by the Board of Directors.

**ARTICLE III
PURPOSE**

The corporation is organized exclusively for charitable, educational, civic, cultural and other exempt purposes.

**ARTICLE IV
BOARD OF DIRECTORS**

The affairs of the corporation will be managed by a Board of Directors. The number of directors that will constitute the Board of Directors of the corporation is four (4). The number of directors may be increased or decreased from time to time, in the manner provided in the bylaws. The method of election or appointment of members to the Board of Directors of the corporation, and the manner of their admission and duration of their terms, are provided for in the bylaws of the corporation. **ARTICLE VI
DISSOLUTION**

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for educational and charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

**ARTICLE VII

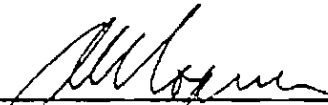

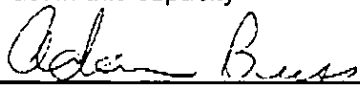
