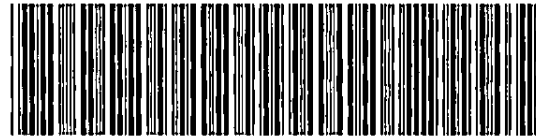

Article I - Name

The name of this Florida not-for-profit corporation is:

Article III - Purpose

The Corporation is organized exclusively for charitable, religious, restoring, educational, resources and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt organizations under the section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code and including the following specific purposes:

To educate the public and advocate on behalf of citizens, youth and their families who are adversely impacted by gun violence; to honor our lost loved ones; to assist the homelessness; to raise national awareness of the existence of excessive and unauthorized crimes in our neighborhood; to assist families in addition to empowering them in re-build their lives one step at a time.

Notwithstanding and other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise and powers that are not in furtherance of the purpose of this Corporation.

Article IV – Membership

The Corporation shall not have members.

Article V – Registered Agent

Article VI – Limitations

The Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on the propaganda or otherwise attempting to influence legislation, except as otherwise provided in Internal Revenue Code Section 501(h) or the corresponding section of any future federal tax code. The Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities except those permitted to be carried on by a corporation exempt from federal income tax under Internal Revenue Code Section 501(c)(3), or the corresponding section of any future federal tax code, and which entitle contributions to the Corporation to deduct their charitable contribution under Internal Revenue Code Section 170(e), or the corresponding section of any future federal tax code.

Article VII – Initial Officers/Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of three directors initially. The number of directors may be increased or diminished from time to time but shall not be less than three of Officers/Directors. The directors shall be protected from personal liability to the fullest extent by law. The initial names are as follows:

Article VIII – Manner of Election of Directors

The directors shall continue in office until such time as they resign, are moved or unable to continue to serve. Any vacancy on the of Directors shall be filled by the affirmative vote of a majority of the Board of Directors then in office, through less than a quorum, or by a sole remaining director and the directors so chosen shall hold office until their subsequent resignation, removal or inability to continue to serve. In the event that at any time there are no directors then in office then the President/CEO of LIVE TO SERVE – LIVE TO CARE INC., a Florida not-for-profit corporation shall appoint a new Board of Director(s).

Upon the dissolution or winding up of the Corporation, the assets remaining after payment (or provision for payment) of the Corporation's debts and liabilities shall be distributed to a not-for-profit fund, foundation or corporation that has established its tax exempt status under internal Revenue Code Section 501c(3) or the corresponding section of any future federal tax code.
