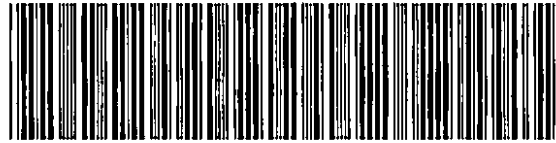

ARTICLES OF INCORPORATION

For

This House Has a Door, Inc.

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

Name: The name of the corporation shall be: This House Has a Door, Inc.

ARTICLE II

Principal Office: The Principal Office of the Corporation shall be:

13900 County Road 455, Suite 107 #331, Clermont, FL 34711

ARTICLE III

Purpose: This corporation is organized as a nonprofit entity exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, such as, but not limited to, the prevention of family and intimate partner violence, educating the community on the signs and patterns of abusive behavior, counseling, informational seminars, tabling at appropriate venues and advocate training. The organization web site also serves as a resource and education hub for domestic violence awareness.

ARTICLE IV

Non-Inurement: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above in Article III.

ARTICLE V

Dissolution: Upon the dissolution of the corporation, assets shall be distributed to a like organization exempt under the Internal Revenue Code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
