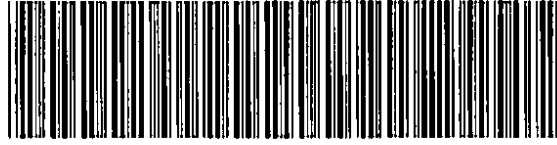

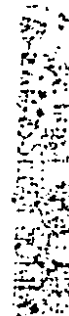

ARTICLES I

ARTICLES II

The Corporation is organized exclusively for charitable, religious, scientific and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to hold any property, or any undivided interest therein, without limitation as to the amount or value, to dispose of any such property to invest, reinvest, or deal with the principal or the income in such manner without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the by-laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for pecuniary profit of financial gain of its directors or officers except as permitted under the Not-for-profit Corporation Law.

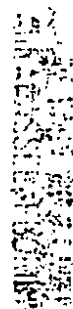

ARTICLE I ORGANIZATION

The name of the organization shall be:
Share the GRACE International Inc.

The organization shall have a seal, which shall be the following form:
Share the GRACE International Inc.

Shall be the seal of corporation, which is in circular form.

ARTICLE II PURPOSES

We will offer Praise and Worship Service, Bible Study at least once a week, these services will allow people to come and learn the teaching of Jesus Christ while offering up Praise and worship.

ARTICLE III MEMBERSHIP

This organization shall be open to all who wish to be a part of it and desire a better life style.

ARTICLE IV MEETING

The annual meeting of this organization shall be held on the 3rd Saturday of January every year except if such day is a legal holiday, then and in that event, the directors shall fix the day but it shall not be more than two weeks from the date fixed by these by-laws.

The Secretary shall cause to be mailed to every member in good standing at his/her addresses as it appears in the membership roll book in this organization a notice telling time and place of such annual meeting. Regular meeting of this organization shall be held the third Saturday of each month.

The presence of no less than fifty one percent (51 %) of the members shall constitute a quorum and shall be necessary to conduct the business of this organization; but a lesser percentage may adjourn the meeting for a period of not more than three (3) weeks from the date.

Scheduled by these By-laws and the secretary shall cause a notice of this meeting to be sent to all those members who were not present at the meeting originally called. A quorum as herein before set forth shall be required at any adjourned meeting.

Special meetings of this organization may be called by the president when she/he deems it for the best interest of the organization. Notices of such meeting shall be mailed to all members at their addresses as they appear in the roll book at least ten (10) days before the scheduled date set for such special meeting. Such notice shall state the reasons that such meeting has been called, the business to be transacted at such meeting and by whom it was called. At the request of twenty-percent (20%) of the Officers or thirty percent (30%) of the members of the organization, the president shall cause a special meeting to be called but such request must be as in writing at least ten (10) days before the requested scheduled date.

No other business but that specified in the notice may be transacted at such special meeting without the unanimous consent of all present at such meeting.

ARTICLE V VOTING

At all meetings, except for the election of officers, all votes shall be by voice. For election of officers, ballots shall be provided and there shall not appear any place on such ballot that might tend to indicate the person who counts such ballot. At any regular or special meeting, if a majority so requires, any question may be voted upon in the manner and style provided for election of officers. The Chairperson of such meeting, shall, prior to the commencement of balloting, appoint a committee of three who shall act as

"Inspectors of Election" and who shall, at the conclusion of such balloting, certify in writing to the Chairperson the results and the certified copy shall be physically affixed in the minute book to the minutes of that meeting.

No inspector of election shall be a candidate for office or shall be personally interested in the question voted upon.

ARTICLE VII BOARD of DIRECTORS AND ADVISORS

The Advisors to be chosen for the ensuing year shall be chosen at the annual meeting of this organization in the same manner and style as the officers of this organization.

Fifty one percent (51%) of the members of the Board of Directors shall constitute a quorum and the meetings of the Board of directors shall be held regularly on the every third Wednesday of each month.

Each director shall have one vote and such voting may be done by proxy.

The director may make such rules and regulations covering its meetings as it may in its discretion determine necessary.

Vacancies in the Board of directors shall be filled by a vote of the majority of the remaining members of the Board of directors for the balance of the year.

The President of the organization by virtue of his/her office shall be Chairperson of the Board of directors. The Board of Advisors shall select from one of their members a secretary.

A director or advisor may be removed when sufficient cause exists for such removal. The Board of director may entertain charges against any Advisor or director.

The President:

He/she shall preside at all membership meetings.

He/she shall by virtue of his office be Chairman of the Board of directors.

He/she shall present at each annual meeting of the organization an annual report of the work of the organization.

He/she appoints all committees, temporary or permanent.

He/she shall see that all books; reports and certificates required by law are properly kept on file.

He/she shall be one of the officers who may sign the checks or drafts of the organization.

He/she shall have such powers as may be reasonably construed as belonging to the chief executive of any organization.

The Vice President:

He/she shall assist the President in all matters concerning the operation of the organization, as the president deems necessary and needed to include public speaking engagements, facilitating workshops and meetings and counseling.

He/she shall in the event of the absence or inability of the President to exercise her/his office Vice-president becomes acting co.-president of the organization with presiding officers.

The Secretary:

He/she shall keep the minutes and records of the organization in appropriate books.

CONFLICT OF INTEREST POLICY
of
Share the GRACE International Inc.

Article I
Purpose

The purpose of the Conflicts of Interest Policy is to protect this tax-exempt organization's (organization) interest when it is contemplating into a transaction or arrangement that might benefit the private interest of an officer or director of the organization or might result in a possible excess benefit transaction. This policy is intended to supplement but not replace any applicable state and federal laws governing conflict of interest applicable to nonprofit and charitable organizations.

Article II
Definitions

1. Interested Person

Any director, principal officer, or member of a committee with governing board delegated powers, which has a direct or indirect financial interest. As defined below, is an interested person. Conflicts of commitment arise when directors are officers involved in outside activities that substantially interfere with their primary responsibility to: Share the GRACE International Inc.

2. Financial Interest

A person has a financial interest if the person has, directly or indirectly, through business, investment, or family:

- a. A ownership or investment interest in any entity with which the organization has a transaction or arrangement,
- b. A compensation arrangement with the organization or with any entity or individual with which the organization has a transaction or arrangement, or
- c. A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the organization is negotiating a transaction or arrangement.

Compensation includes direct and indirect remuneration as well as gifts or favors that are not insubstantial. A financial interest is not necessarily a conflict of interest. Under Article III, section 2, a person who has a financial interest may have a conflict of interest only if the appropriate governing board or committee decides that a conflict of interest exists.

Article 111 Procedures

1. Duty of Disclose

In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the director and members of committee with governing board delegated powers considering the proposed transaction or arrangement.

2. Determining Whether a Conflict of Interest Exists

After disclosure of the financial interest and all material facts, and after any discussion with the interest person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest exists.

3. Procedures of Addressing the Conflict of Interest

- a. An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest.
- b. The chairperson of the governing or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.
- c. After exercising due diligence, the governing board or committee shall determine whether the organization can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.
- d. If a more advantageous transaction or arrangement is not reasonably possible under circumstance not producing a conflict of interest, the transaction or arrangement is in the organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.

4. Violations of the Conflicts of Interest Policy

- a. If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform

the members of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose.

b. If, after hearing the member's response and after making further investigation as warranted by the circumstance the governing board or committee determines the member had failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Article IV Records of Proceedings

The minutes of the governing board and all committee with board delegated powers shall contain:

a. The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the governing boards or committee decision as to whether a conflict of interest in fact existed.

b. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, which including any alternatives to the proposed transaction or arrangement and a record of any votes taken in connection with the proceedings.

Article V Compensation

a. A voting member of the governing board who receives compensation, directly or indirectly, from the organization for services is precluded from voting on matters pertaining to that member's compensation.

b. A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly, or indirectly, from the organization for services is precluded from voting on matters pertaining to that member's compensation.

c. No voting member of the governing board or any committee whose jurisdiction includes compensation matters and prohibited from providing information to any committee regarding compensation.

Article VI Annual Statements

Each director, principal officer and member of a committee with governing board delegated powers shall annually sign a statement which affirms such person:

- a. Has received a copy of the conflicts of interest policy.
- b. Has read and understands the policy.
- c. Has agreed to comply with the policy, and

d. Understands the organization is charitable and in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purpose.

Article V11

Periodic Reviews

To ensure the organization operates in a manner consistent with charitable purpose and does not engage in activities that could jeopardize its tax-exempt status, periodic shall be conducted. The periodic reviews shall, at a minimum, include the following subject:

- a. Whether compensation arrangements and benefits are reasonable, based on competent survey information and the result of arm's length bargaining.
- b. Whether partnership, joint ventures, and arrangements with management organization conform to the organization's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes and do not result in increment, impermissible private benefit or in an excess benefit transaction.

Article V111

Use of Outside Experts

When conducting the periodic reviews as provided for in Article V11, the organization may, but need not, use outside advisors. If outside experts are used, their use shall not relieve the governing board of its responsibility for ensuring periodic reviews are conducted.
