

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, TERRY KRUSE MINISTRIES INC., a Florida non-profit corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation is TERRY KRUSE MINISTRIES INC.
2. The original Articles of Incorporation of the Corporation (the "Articles") were filed on August 27, 2018, and assigned Document No. N18000009256.
3. TERRY KRUSE MINISTRIES INC. is a non-profit corporation and no members exist other than the Board of Directors.
4. The only members qualified to vote and amend the Articles of Incorporation are the officers serving on the Board of Directors.
5. The following amendment of the Articles of Incorporation was adopted on March 24, 2020 by two-thirds (2/3) consent of the Board of Directors who are entitled to vote, and by which is a sufficient number of votes cast for such amendment necessary for the approval thereof.
6. Article III of the Articles of Incorporation is hereby amended and restated in its entirety and replaced with the following:

Article III

TERRY KRUSE MINISTRIES INC. is a faith-based (Christian) organization with a goal of providing an internet ministry blogsite displaying content regarding teachings of the Holy Bible. TERRY KRUSE MINISTRIES INC.'s goal is also to provide ancillary church services including pastors conferences, layman training conferences and missions conferences (national and international) that benefits churches.

TERRY KRUSE MINISTRIES INC. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to

the federal government, or to a state or local government, for a public purposes. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

IN WITNESS WHEREOF, these Articles of Amendment have been executed on behalf of the Corporation by its President on this 25th day of March, 2020.
