Article Amendment

Article III of the Articles of Incorporation is amended to read as follows:

The specific purpose of this corporation is to provide a program that unlocks Jacksonville youth's hidden potential and empower them to achieve lifelong success by equipping them with life's necessary tools through nurture and experiences. We will provide a learning center where students can participate in enrichment activities; build relationships with peers and work on academic goals through hands-on education and job-training. The corporation will provide assistance to underprivileged, low-income. mistreated and maladjusted children, youths and young adults by offering mentoring and encouragement. through sponsoring educational programs, professional training, mentoring, advocacy, and supportive services that help uplift the entire community. The key objective is to strengthen our community through development, leadership, cooperative learning, elevating self-esteem and fostering multi-cultural exchange. Our program will early education aid for underprivileged children who have been excluded from the traditional pathways to career formation and advancement by protracted poverty. Our program will work with life management, social skills, and literacy for low-income youth that are underserved, handicapped. under privileged, disenfranchised and disadvantaged. The Corporation is to offer services that empower each youth with knowledge and resources to achieve greater self-identity, academic excellence, community involvement and balanced living.
