ARTICLES OF INCORPORATION OF THE HORAN FAMILY FOUNDATION, INC.

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes do hereby certify:

ARTICLE 1

NAME

The name of the Corporation shall be the HORAN FAMILY FOUNDATION, INC.

ARTICLE 2 PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is to be located is 243 Ponce de Leon Avenue Venice, Sarasota County, Florida 34285

ARTICLE 3 DURATION

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

ARTICLE 4 PURPOSE

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 5

POWERS

This corporation shall have the power to do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation, including, but not limited to, power to perform contracts for any lawful purpose, to engage in various funding and fund raising activities, and to acquire, hold, operate, maintain, and lease real and personal property to effectuate its purposes.

ARTICLE 6

PROHIBITED ACTIVITIES AND REQUIRED PROVISIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in Article 4 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, nor shall it carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internai Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

As required by the Internal Revenue Code and as provided in the Florida Not For Profit Corporation Act, Chapter 617, Section 0835, Florida Statutes, the corporation will: (1) distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code; (2) not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code; (3) not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code; (4) not make any investments in a manner so as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any, (5) not make any taxable expenditures as defined in section 4945 of the Internal Revenue Code, or the corresponding section for the corresponding section of any future federal tax code; and, (5)

ARTICLE 7 MEMBERS

This corporation is organized upon a non-stock basis and shall have no members.

ARTICLE 8

INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of this corporation is 99 Nesbit Street, Punta Gorda, Florida 33950, and the name of the initial registered agent of this corporation at that address is Forrest J. Bass, Esq.

ARTICLE 9 INITIAL BOARD OF DIRECTORS

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by its Board of Directors. This corporation shall have four (4) (at least 3 required) directors initially. The number of directors may be increased or diminished from time to time as set out in the bylaws of this corporation. The names and addresses of the initial directors are as follows:

ARTICLE 11 INCORPORATOR

The name and address of the incorporator is Forrest J. Bass, 99 Nesbit Street, Punta Gorda, Florida 33950.

ARTICLE 12 DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 13 AMENDMENTS

These Articles of Incorporation may be amended by a two-thirds (2/3) vote of the Directors. Notwithstanding the Directors' power to amend these Articles of Incorporation, the initial Directors shall remain directors until their death or resignation.
