Articles of Incorporation of

The Cancer Survivor Foundation, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Currently, there are nonprofits raising billions of dollars that go to cancer research and helping patients in active treatment. But once you are declared "cancer free" you are left completely on your own - in mountains of medical debt, STILL suffering long-term side-effects of treatment that cause social isolation and inability to return to work full time right away, and everyone expects you to just be "happy to be alive," but you are frightened - scared the next shoe will drop and that nobody understands that the healing process is a long one. I know because I'm two years out of a breast cancer diagnosis at only the age of 42. And even though I can burely feed myself or keep a roof over my head due to the debt or eve continue my medical care, nor do I have any real social support out there as everyone cheers on the "fighters," When I tried to call the American Cancer Society and Susan G Koman organizations, they literally told me that there was nothing they could do for me. I was ()NE of the - a fighter, a survivor, dressed head to toe in pink supporting their cause. And they told me they didn't have a dollar allocated to help people like me - young women who were very well-educated, with prior highly successful careers, left with sears both mentally and physically that changed us, struggling to make it, had NO one to turn to. So all of these corporate donors who think their charity money is going to help EVERYONE is wrong! I want to start a foundation that Just focuses on those of us who are starting the Second Battle in the war with cancer: recovery. Maybe we were "cured," but we still suffer. And we need assistance. There should be an organization out there that offers it.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
