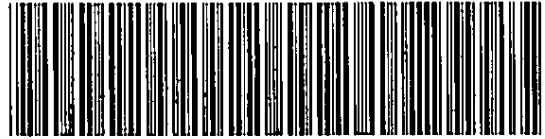

**Article I**  
**Name**

The name of the corporation shall be VetMed Class of 2021 Inc. (the "Organization").

**Article II**  
**Principal Office and Mailing Address**

The physical and mailing address of the principal office of the Organization shall be 2015 SW 16<sup>th</sup> Avenue, Gainesville, FL 32608.

**Article III**  
**Purpose**

This Organization is a not-for-profit organization to be operated exclusively for education, pleasure, recreation, and similar purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit. The Organization shall be operated exclusively to support the educational mission of graduating competent veterinarians in four years. During this process, the Organization will raise funds in order to supplement educational opportunities with speakers, ceremonies, and meetings.

**Article IV**  
**Membership**

The Organization shall have no stockholders or owner-members.

**Article V**  
**Initial Registered Office and Agent**

The street address of the initial registered office of the Organization is 2015 SW 16<sup>th</sup> Avenue, Gainesville, FL 32608, and the name of the Organization's initial registered agent at that address is Kimberly Brady.

**Article VI**  
**Board of Directors**

The affairs of the Organization shall be managed by an Executive Board. The number of officers shall initially be four. The number of officers may be increased or decreased from time to time as set forth in the constitution of the Organization, but shall never be less than three. The manner of election of the officers shall be as set forth in the constitution of the Organization. The name and addresses of the persons who shall serve as the initial officers are as follows:

#### **Article VIII Dissolution**

Upon the dissolution of the Organization, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Organization shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Code (or the corresponding provision of any future federal tax laws), as determined in the constitution of the Organization.

#### **Article IX Limitations**

No part of the net earnings of the Organization shall inure to the benefit of its officers, directors, or other private persons, except that the Organization shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of any of its charitable purposes. No part of the activities of the Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided in subsection (b) of Section 501 of the Code), and the Organization shall not participate or intervene in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the Organization shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future federal tax law), or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future federal tax law).

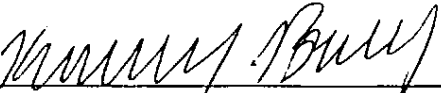
