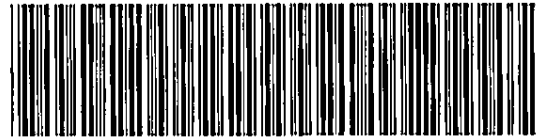





### THE WINCREDIBLE WINSTITUTION PURPOSES & DISSOLUTION

- A. To create a venue for inner-city youth in low-income communities that empowers them through hands on training, educational materials, awareness, structure, support and guidance; and to provide a vehicle for them that would be the driving force that helps them to be able to compete across the board within this 21<sup>st</sup> century technological wave as they become future leaders within the community at large.
- B. To plan, develop, and coordinate a mentoring program that builds self-esteem, promotes leadership, community service, internships, peer education individual/group counseling and one that is a model for success by collaborating with educators, industry professionals, and community partners that will inspire these inner-city youth to dream big and be great through effective informational sessions, empowerment and real life experiences.
- C. To foster continuing education and academic achievement for low-performing students by providing after school tutorial assistance, a summer day camp program, literacy, computer literacy, educational workshops, life building skills, career development/job readiness, scholarships and an economic development program that will empower individuals to become productive citizens.
- D. To develop strategies towards enhancing the social & physical betterment of inner-city youth in low-income communities by incorporating workshops that will educate and prepare these youth to reach their full potential; and to promote the general welfare of the community at large by providing seminars, conferences, community outreach and charitable services to families in need that will promote health & wellness, stability, gainful employment and self-sufficiency.
- E. To provide services to all qualifying clients, in accordance with all applicable state and federal anti-discrimination statutes and to do any other thing incidental to or connected with the forgoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors or officers, except as permitted under Article 5 of the Not-For-Profit Corporation Law.
- F. To have and exercise all rights and powers conferred on non-profit corporations under the laws of the State of Florida, or which may be hereafter conferred, including the power to contract, rent, buy or sell personal property; provided, however, that the Corporation will not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of The Winccredible Winstitution, Inc.

Notwithstanding any other provision of these articles the corporation was organized exclusively for one or more purposes as specified in 501© 3 of the Internal Revenue Code of 1954 (the "IRC"), and shall not carry on activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC 501© 3 or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of this corporation shall insure to the benefit member, trustee, director, officer, of the corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by the by IRC 501 (h)), and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

In event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC 501 © 3 or corresponding provisions of any subsequent Federal tax laws, or to the government, or state, or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

In any taxable year in which this corporation is a private foundation as described in IRC 509 (a), the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under IRC 4942, and the corporation shall not (a) engage in any act of self-dealing as defined in IRC 4941 (d), retain any excess business holdings as defined in IRC 4943 (c), (b) make any investments in such manner as to subject the corporation to tax under IRC 4944, or (c) make any taxable expenditures as defined in IRC4945 (d), or corresponding provisions of any subsequent Federal tax Laws.
