The undersigned President of BRIGHT FUTURES VOCATIONAL TRAINING, INC., executes these Restatement of Articles of Incorporation of BRIGHT FUTURES VOCATIONAL TRAINING, INC., pursuant to Chapter 617 of the Florida Statutes.

**ARTICLE 1 - NAME**

The name of the Corporation is BRIGHT FUTURES VOCATIONAL TRAINING, INC., (hereinafter, "Corporation").

**ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these Restatement of Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal

Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




