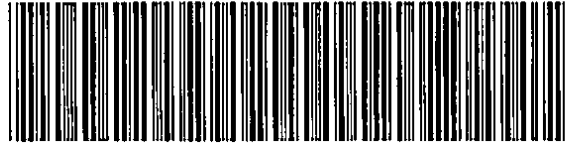

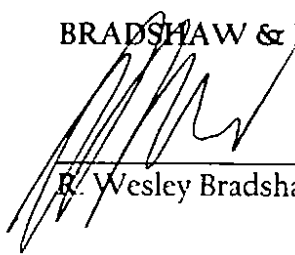

**ARTICLES OF INCORPORATION
OF
CITRUS COUNTY COALITION FOR COLLEGE & CAREERS, INC.
A Florida Corporation Not for Profit**

I, the undersigned, acting as incorporator of the non-profit corporation under Chapter 617 of the Florida Statutes, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I – NAME AND PRINCIPAL OFFICE

The name of the Corporation Not for Profit shall be the **CITRUS COUNTY COALITION FOR COLLEGE & CAREERS, INC.** ("Corporation"). The initial principal office and mailing address of the Corporation shall be 681 West Britain Street, Hernando, Florida 34442.

ARTICLE II – DURATION

The Corporation shall commence corporate existence on the date these Articles of Incorporation are accepted and filed with the Florida Department of State and shall have perpetual existence unless dissolved sooner by law.

ARTICLE IV – PURPOSE

The Corporation is organized and shall be operated at all times exclusively for exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and its regulation as they now exist or as they may hereafter be amended, or a corresponding section of any future federal tax code (the "Code"). Subject to the foregoing, the specific purposes and objectives of the Corporation shall include but not be limited mentoring, tutoring, and raising of fund through fundraising activities and contributions to provide college preparation and scholarships to students residing in Citrus County, Florida, who

demonstrate appropriate need and merit. The Corporation is organized and shall operate exclusively for the purposes set forth above. No part of any net earnings or assets of the Corporation will inure to the benefit of any member.

ARTICLE IV – POWERS

The Corporation shall possess and may exercise all the powers and privileges granted in Chapter 617 of the Florida Statutes.

ARTICLE IV – MEMBERS AND BYLAWS

The qualifications of members and the manner of their admission shall be as regulated by the Bylaws. The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors.

ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT

The street name of the initial registered office the Corporation shall be 681 West Britain Street, Hernando, Florida 34442 and the initial registered agent of the Corporation at that address is Patrick M. Simon.

ARTICLE VI – DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as may be amended, or shall be distributed to a State or Federal government for a public purpose.

ARTICLE VII – BOARD OF DIRECTORS

The directors of the Corporation shall be elected in accordance with the methods and qualifications specified in the Bylaws of the Corporation. In no event, shall the number of directors be fewer than five (5).

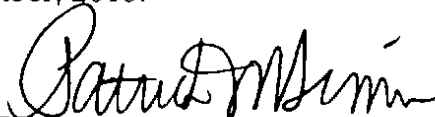

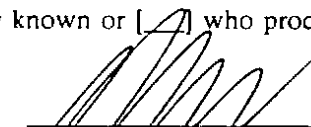

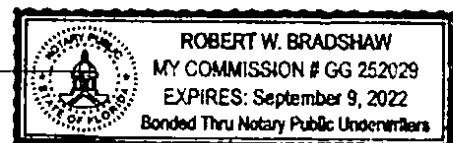
