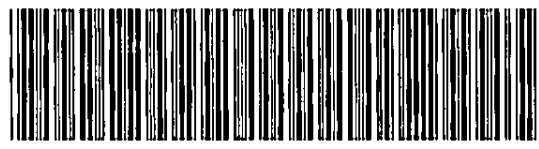

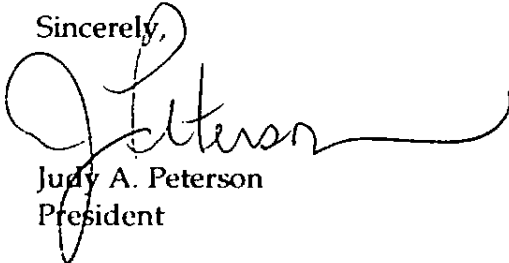

**ARTICLES OF INCORPORATION
OF
JUDY PETERSON WORLD MINISTRIES, INC.
(FLORIDA CORPORATION NOT FOR PROFIT)**

The undersigned, acting as incorporator of a Florida Corporation not-for-profit under the Florida Not-for-Profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopt the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation shall be Judy Peterson World Ministries, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of the Corporation is 4409 Hoffner Avenue, Suite 173, Orlando, Florida 32812.

**ARTICLE III
PURPOSE**

The purpose for which this corporation is organized includes but not limited to:

- a) creating and establishing youth enrichment empowerment programs;
- b) hosting and promoting motivational speaking, seminars and conferences;
- c) mentoring and establishing self-esteem training programs;
- d) establish programs to assist in providing opportunities to economically disadvantage individuals to become self-sufficient and productive;
- e) create programs to foster education, cultivate the arts, entertainment, musical training, and musical therapy;
- f) establishing programs internationally;
- g) and any all lawful business.

ARTICLE VII
REGISTERED OFFICE AND AGENT

ARTICLE VIII
NO DISTRIBUTION OF PROFITS

The Corporation is not organized for pecuniary profit. The Corporation shall not have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director or individual. The balance, if any, of all monies received by the Corporation from its operations, after the payment in full of all debts and obligations of the Corporation, of whatever kind of nature, shall be issued and distributed exclusively for non profit purposes.

ARTICLE IX
PROHIBITION AGAINST POLITICAL ACTIVITIES

No substantial part of the activities of the Corporation shall be devoted to the promulgation of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office.

ARTICLE X
DISTRIBUTION OF ASSETS UPON DISSOLUTION

In the event of the dissolution of the Corporation, all the business, property and assets of the Corporation shall go and be distributed to such non-profit religious corporation(s), as may be selected by the Board of Directors of the Corporation. In no way shall any of the assets or property of the Corporation shall then be used for and devoted for anything other than for charitable purposes.

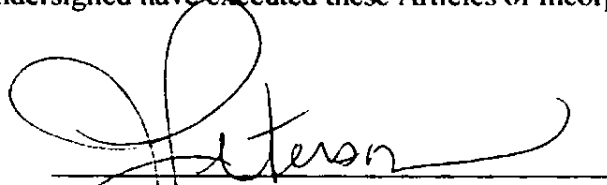

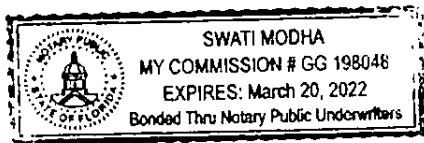

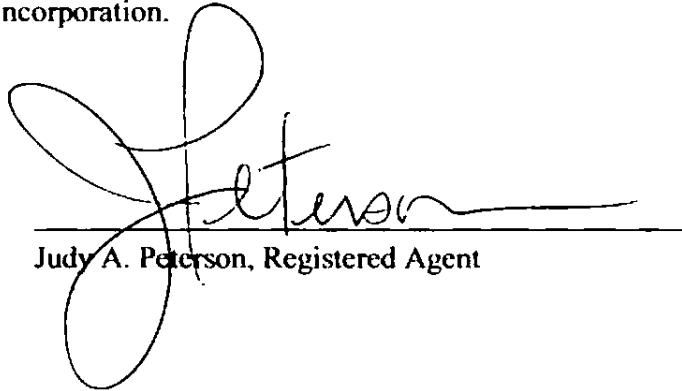
