Articles of Incorporation

In Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned, who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I Name

The name of the corporation shall be: Johannes Ballplayer Development Charity, Inc.

Article II Principal Office

The principal street address is 1794 NW 34th Street, Gainesville, Florida 32605 (Alachua County).

Article III Purpose

The corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation will collect through charity events and unpaid volunteer activities funds that are distributed with approval of the Board and advice from key knowledgeable sports and subject matter experts. The charity focus is youth baseball and softball sport participants in three categories:
