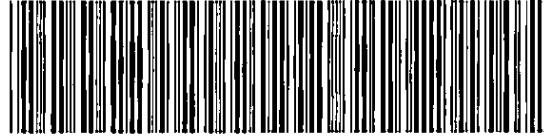



**ARTICLES OF INCORPORATION  
OF  
EMMAUS BIBLE CHAPEL, INC.**

These Articles of Incorporation are hereby made and acknowledged by the undersigned, who desires to form a not-for-profit corporation under the Florida Not For Profit Corporation Act (Chapter 617, Florida Statutes) and who does hereby certify:

**Article 1.  
Name and Principal Office**

The name of this Corporation shall be **EMMAUS BIBLE CHAPEL, INC.** The street and mailing address of the place of business in Florida is:

**Article 2.  
Corporate Purposes**

The Corporation shall be a nonprofit organization formed and operated exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including the making of distributions to religious organizations that qualify as exempt organizations under Section 501(c)(3), and specifically to gather as believers in Jesus Christ in the pattern established in the New Testament.

**Article 3.  
Powers**

The Corporation shall have and exercise all powers accorded not-for-profit corporations under the laws of the State of Florida.

**Article 4.  
Term of Corporate Existence**

This Corporation shall exist perpetually unless dissolved according to law.


