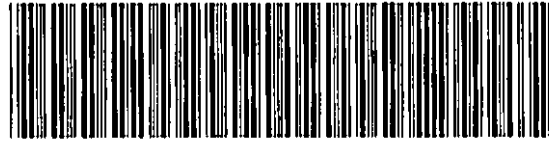

#### **ARTICLE IV**

**Statement of Purpose:** This Corporation is organized as a Nonprofit Entity exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, such as, but not limited to, proclaiming the Gospel of the Lord Jesus Christ; establishing and maintaining religious worship; educating believers in a *manner* consistent with the requirements of the Holy Scripture; and maintaining missionary activities in the United States and any foreign country.

#### **ARTICLE VI**

**Manner of Election:** The Board of Directors shall be appointed in a manner as provided for in the bylaws.

## ARTICLE VII

**Non-Inurement:** No part of the net earnings of this Non-Profit Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this Non-Profit Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions *in furtherance of the* purposes set forth above in Article IV.

## ARTICLE XI

**Dissolution:** Upon the dissolution of this Non-Profit Corporation, assets shall be distributed to a like organization exempt under the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
