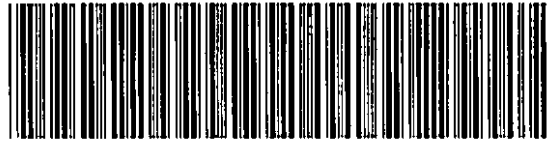

ARTICLE I.-NAME

The name of this corporation is Scarlett's Sunshine, Inc.

ARTICLE II.-PRINCIPAL PLACE OF BUSINESS

The name and address of the incorporator of this corporation is Holly Middleton 6033 Long Bayou Way N. St. Petersburg FL 33708.

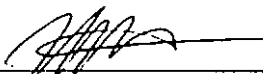
ARTICLE VIII.-AMENDMENTS

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors.

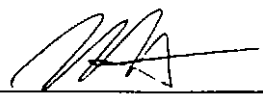
ARTICLE IX.-EFFECTIVE DATE
