As you know, I have the pleasure of representing Ford Dealers Advertising Fund, Inc., Jacksonville Division. We received correspondence from you dated June 26, 2018, indicating that this judicially/legislatively created not for profit corporation must be reincorporated before the name and registered agent changes can be made with your office. Enclosed please find the following documents:

- 1. Correspondence dated September 12, 2018 from Clerk of Duval County indicating the official records regarding Ford Dealers Advertising Fund, Inc. are not available.
- 2. Redacted correspondence from William R. Frazier date August 19, 1991 to Ford Dealers Advertising Fund, Inc. with copies of certified copies of the charter and amendment, both certified by a Duval County Deputy Clerk on August 15, 1991.
- 3. Completed Cover Letter and Application for Reinstatement and Reincorporation.
- 4. Completed Certificate of Reincorporation.
- 5. My firm check in the amount of \$70.00 to cover the filing fee and registered agent fee.
- 6. My firm check in the amount of \$8.75 to cover the certified copy fee.
- 7. My firm check in the amount of \$8.75 to cover the certificate of status fee.
- 8. Articles of Amendment to Articles of Incorporation (my firm's check in the amount of \$52.50 was previously forwarded to cover the filing fee, and certified copy and certificate of status fees).

Darlene located the original charter that was filed April 18, 1939, and indicated we would need to obtain from the Clerk of Duval County certified copies of the original recorded charter and all amendments. The Duval County clerk's office has indicated that there are no records available regarding the original charter documents or any amendments to the charter documents for Ford Dealers Advertising Fund, Inc. Correspondence dated September 12, 2018 from the Clerk of Duval County is enclosed for your reference.

My client located correspondence dated August 19, 1991 from attorney William R. Frazier with copies of certified copies of the original charter and the amendment to the charter. I enclose a redacted copy of Mr. Frazier's letter together with the copies of the certified copies. You will note that as of August 19, 1991 Mr. Frazier represents that the enclosed amendment is the only amendment to the charter. As you know, I have the pleasure of representing Ford Dealers Advertising Fund, Inc., Jacksonville Division. We received correspondence from you dated June 26, 2018, indicating that this judicially/legislatively created not for profit corporation must be reincorporated before the name and registered agent changes can be made with your office. When we called for more explanation, we spoke with a supervisor named Darlene.

Darlene was able to locate the original charter that was filed April 18, 1939, and indicated we would need to obtain from the Clerk of Duval County certified copies of the original recorded charter and all amendments. I have been in contact with the clerk's office in Duval County, and procuring the requested certified copies is taking longer than expected.

We do intend to follow through on the reinstatement/reincorporation procedure you provided in your correspondence, but it is taking longer than the 60 days you allowed. I would respectfully request an open extension to make every effort to obtain the certified documents you have requested and complete your recommended course of action.


