Amended Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit), the undersigned incorporator, for purpose of forming a Florida not-for-profit corporation, hereby adopts the following Amended Articles of Incorporation:

Article I Name

The name of the corporation shall be: SUNDAY STRONG CORP.

Article II Principal Office

The principal street address is: 3780 9TH PLACE, VERO BEACH, FL 32960.

The principal mailing address is: $3780 9^{TH}$ PLACE, VERO BEACH, FL 32960.

Article III Purpose

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation's purpose is to work with gyms and fitness facilities nationwide to offer one, free class a week for adult special needs athletes with the goal of improving overall health and wellness of this population.

Article IV Manner of Election

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

Article VI Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII Dedication of Assets

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. After payment of all bills and proper claims, remaining assets shall be transferred to Special Olympics Florida and/or other non for profits with purposes that support intellectually disabled athletes. The final serving Board of Directors of Sunday Strong Corp. shall select such organization prior to dissolution.
