

Article One: The name of the Corporation shall be <u>Central Florida PTSD Support</u> <u>Group, INC.</u>

Article Three: Said corporation is organized and operated exclusively for charitable purposes set forth under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The organization has been created to help provide relief to people distressed by Post Traumatic Stress Disorder (PTSD) and/or other mental health issues.
