ARTICLES OF INCORPORATION FOR

SOUTHERN RELIEF, INC.

A 501(c)(3) ORGANIZATION OPERATING AS A CORPORATION

ARTICLES OF INCORPORATION of the undersigned, majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I - NAME

1. The name of the Corporation shall be Southern Relief, Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The place in the state with the principal office of the Corporation is to be located in the City of Tallahassee, Leon County.

The street address of the corporation is 1103 Hays Street, Tallahassee, Florida 32301.

The mailing address of the corporation is 1103 Hays Street, Tallahassee, FL 32301.

ARTICLE III - PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, with the corresponding section of any future federal tax code.

Specifically, the corporation is organized to conduct disaster relief efforts that will bring together volunteers prepared to donate time and money to provide supplies and services to citizens affected by natural and other disasters in our area.

ARTICLE IV — MANNER OF ELECTIONS

The manner in which the directors are elected and appointed shall be that at all meetings, except for the election of officers and directors, all votes shall be by voice. For election of officers, ballots shall be provided and there shall not appear any place on such ballot that might tend to indicate the person who cast such ballot.

At any regular or special meeting, if a majority so requires, any question may be voted upon in the manner and style provided for election of officers and directors. At all votes by ballot the Chairman of such meeting shall, prior to the commencement of balloting, appoint a committee of three who shall act as "Inspectors of

Election" and who shall, at the conclusion of such balloting, certify in writing to the Chairman the results and the certified copy shall be physically affixed in the minute book to the minutes of that meeting.

No inspector of election shall be a candidate for office or shall be personally interested in the question voted upon.

ARTICLE V — INITIAL OFFICERS AND/OR DIRECTORS

The names and addresses of the persons who are the initial Officers of the Corporation are as follows:

ARTICLE VI — USE OF EARNINGS/PROHIBITION OF ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except the Corporation shall be authorized and empowered to a recent compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, with a corresponding section of any future federal tax code.

ARTICLE VII — DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as set Court shall determine, which organized and operated exclusively for such purposes.






