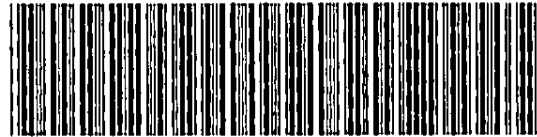

## ARTICLE- VI

### ELECTION PROCESS OF BOD/DIRECTORS

ELECTION OF OFFICERS (BOD, EXECUTIVE BRANCH s.617.0202); BOARD OF DIRECTORS: THE BOARD OF DIRECTORS OF SAID CORPORATION SHALL CONSIST OF THE ORIGINATING OFFICERS WHO'S NAMES HAVE BEEN AFFIXED TO THIS DOCUMENT.

EXECUTIVE BRANCH: THE EXECUTIVE BRANCH SHALL BE ESTABLISHED AND MAINTAINED BY THE BORAD OF DIRECTORS OF SAID CORPORATION, THEREAFTER, BY THE PRESIDENT OF SAID DORPORATION.

TERM LIMITS: THE TERM IN OFFICE OF THE ORIGINATING OFFICERS SHAL BE FOR LIFE OR UNTIL SUCH TIME THAT HE OR SHE MAYBE DEEMED UNFIT TO SERVE PURSUANT TO THE MORAL CLAUSE SAT DOWN IN THIS DOCUMENT (see addendum clause below). SUBSEQUENT OFFICERS MAY SERVE FOR THREE (3) YEARS, AT WHICH TIME HE OR SHE MAY BE REAFFIRMED BY A FULL VOTE OF THE BOARD OF DIRECTORS OF SAID CORPORATION.

VOTING RIGHTS: IN ALL MATTERS, PURSUANT TO THE AUTHORITY OF BOTH THE BOARD OF DIRECTORS AND EXECUTIVE BRANCH OF SAID CORPORATION, REQUIRING A FULL VOTE, EACH OFFICER SHALL BE GRANTED ONE VOTE EACH.

(Addendum) MORAL CLAUSE: MEMBERS OF BOTH THE BOARD OF DIRECTORS AND EXECUTIVE BRANCH OF SAID CORPORATION MUST SUBMIT TO A BACKGROUND CHECK BEFORE DOING ANY WORK OR PARTICIPATING IN ANY ACTIVITY INVOLVING MINORS

## ARTICLE VII

### ORGANIZATION OF SAID CORPORATION (s.617.0840)

BOARD OF DIRECTORS: THE BOARD OF DIRECTORS SHALL BE MADE UP OF NO LESS THAN THREE OF THE ORICINATING OFFICERS; WHOOSE NAME(S) HAS BEEN AFFIXED TO THIS DOCUMENT.

EXECUTIVE BOARD: (STRUCTURE): THE EXECUTIVE BOARD SHALL BE MADE UP OF THE FOLLOWING: (1). PRESIDENT, (2): VICE PRESIDENT, (3): EXECUTIVE SECRETARY, (4): TREASURER/BOOKKEEPER

GENERAL MEMBERSHIP: SHALL BE BY INVITATION ONLY. INVITATION FOR MEMBERSHIP WILL BE EXTENDED AND GRANTED BY MEMBERS OF THE BOARD OF DIRECTORS AND THE EXECUTIVE BRANCH OF SAID CORPORATION.

**MEETINGS s.617.0820:** (a) BOARD MEETINGS: THE OPERATING BOARD OF SAID CORPORATION SHALL MEET NO LESS THAN THREE TIMES PER CALENDAR YEAR, AT A LOCATION, DATE /TIME, THAT HAVE BEEN PUBLISHED NO LESS THAN TWO (2) WEEKS PRIOR TO ASSEMBLY.

### **ARTICLE VIII**

#### **GOVERNMENT OF SAID CORPORATION (s.617.0840)**

**BOARD OF DIRECTORS:** THE PRIMARY FUNCTION OF THE BOARD OF DIRECTORS SHALL BE, BUT NOT LIMITED TO: PLANNING/ORGANIZATION AND THE OVERALL OPERATION OF SAID CORPORATION.

**PRESIDENT:** THE PRIMARY FUNCTION OF THE PRESIDENT SHALL BE THE DIRECTION OF THE DAY TO DAY OPERATION OF SAID CORPORATION.

**VICE PRESIDENT:** WILL ASSUME THE DUTIES OF THE PRESIDENT IN HIS OR HER ABSENCE, AND ASSIST THE PRESIDENT WITH THE DAY TO DAY OPERATION.

MEMBERSHIP INTO SAID CORPORATION SHALL BE BY INVITATION ONLY, GRANTED AND APPROVED BY A FULL VOTE OF THE SITTING BOARD OF DIRECTORS. INVITATION FOR MEMBERSHIP INTO SAID CORPORATION SHALL BE WITHOUT REGARDS OF RACE, RELIGION, ETHNICITY, NATIONAL ORIGIN, OR SEX (MALE OR FEMALE).

**GENERAL MEETING:** SHALL BE CALLED FOR THE PURPOSE OF DISSEMINATING INFORMATION AS TO THE STATUS OF SAID CORPORATION AND ITS FUTURE PLANNING OF PROGRAMS AND ACTIVITIES. MEETINGS SHALL BE CALLED AS DEEMED NECESSARY BY GOVERNING BOARD OF DIRECTORS/EXECUTIVE BRANCH.

**ARTICLE X**

(DISSOLUTION: s.617.1402)

IN THE EVENT THAT SAID CORPORATION SHOULD FAILED TO COMPLY WITH THIS CORPORATION'S ARTICLES OF CORPORATION OR STATE STATUES PERTAINING TO THE OPERATION GOVERNMENT OF CORPORATION NOT FOR PROFIT, THIS CORPORATION BY ORDER OF THE STATE SHALL BE DISOLVED, AND ITS ASSETS DISTRIBUTED ACCORDINGLY.
