**ARTICLE I  
CORPORATE NAME**

**ARTICLE IV  
GENERAL AND SPECIFIC PURPOSES**

**Section I – General Purpose**

CHURCH OF THE CREATOR, INC., exists to represent faith in the Sun as the creator of everyone and of all things. This first ancient faith from which all existing religions have come is our faith.

Said corporation will govern itself and conduct its own affairs according to our beliefs. This right shall include such matters as the hiring employees, election of the Board of Directors and Officers, the acceptance and discipline of its members, the conduct of its own services and all business matters.

## **Section II – Internal Revenue Service**

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

- (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or
- (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

## **ARTICLE V AFFILIATION**

While maintaining its inherent rights to sovereignty in the conduct of its own affairs as herein set forth, the Church voluntarily commits to enter into fellowship and partnership with like-minded and charged organizations as it sees fit or is necessary to accomplish its mission.

## **ARTICLE VI LEADERSHIP**

The Board of Directors shall govern this organization and are authorized to purchase, mortgage, encumber, and sell part or all the Corporations real property and personal assets. The Board of Directors are also authorized to apply for all

The board of directors and officers of the corporation shall be persons of mature beliefs in our faith. The way the directors and officers are elected or appointed shall be set forth in the Constitution and Bylaws.

**ARTICLE IX  
DISSOLUTION**

Upon the dissolution of the organization, none of its funds or assets shall be distributed to any director, officer, trustee, member or any other individual. The church board shall, after paying or making provision for the payment of all of the liabilities of the church, distribute funds and assets for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such religious purpose.

#### ARTICLE XII: INDEMNIFICATION

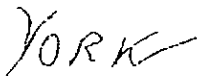

These Articles of Incorporation may be amended at any time by a 2/3rds vote of the registered membership of the corporation at any regular meeting of the membership or at a special meeting called for that purpose.
