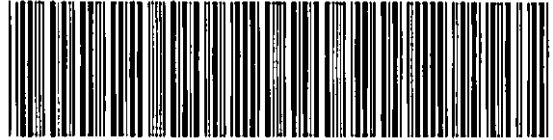

Section I – General Purpose

CHURCH OF THE CREATOR, INC., exists to represent faith in the Sun as the Creator of everyone and of all things.

This first ancient faith from which all existing religions have come is our faith. The modern name of this faith is Sunnynity.

The CHURCH OF THE CREATOR, INC. is the first Sunnynity denomination church.

The CHURCH OF THE CREATOR, INC. is the Mother Church of the Sunnynity religion and the central organization for all churches, sanctuaries and other organizations, as well as all communities of the Sunnynity religion.

Said corporation will govern itself and conduct its own affairs according to our beliefs.

This right shall include such matters as the hiring employees, election of the Board of Directors and Officers, the acceptance and discipline of its members, the conduct of its own services and all business matters.
