## ARTICLE III PURPOSE

This corporation is organized and shall operate exclusively for educational, cultural, charitable and scientific purposes and to make gifts, grants, loans and subsidies to other charitable and/or education organizations described in Section 501(c)(3) of the Internal Revenue Code; such purpose shall include, but not be limited to, the provision of affordable housing to extremely low, very low-income, low income and moderate income persons, and to foster low-income housing.
