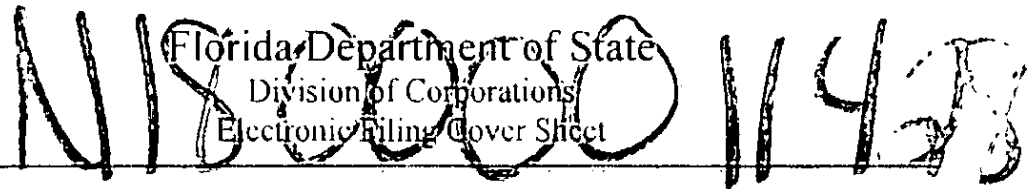

TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of sections 601.1007 *et seq.* of the Florida Not For Profit Corporation Act, the Sole Member named below causes these Articles of Amendment to the Articles of Incorporation to be delivered to the Florida Secretary of State for filing, and states as follows:

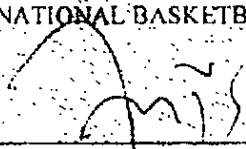
1. The name of the entity is FIBA AMERICAS, INC.
2. The entity name of the corporation is hereby changed from FIBA AMERICAS, INC. to FIBA IN THE AMERICAS, INC.
3. ARTICLE I of the Articles of Incorporation of the corporation is deleted in its entirety and a new ARTICLE I is inserted in lieu thereof reading in its entirety as follows:

The name of the corporation (the "Corporation") shall be: FIBA in the Americas, Inc.
4. This amendment was approved by the Sole Member of the Corporation, the Fédération Internationale de Basketball ("FIBA"), on April 30, 2021. The number of votes in favor of the amendment were 1, with no votes against, which is sufficient for adoption of the amendment as there is only one member of the Corporation.
