AMENDED ARTICLES OF INCORPORATION - JANUARY 1ST, 2022

for

BusinessFlare Academy, Inc.

A Florida Not-for-Profit, Public Benefit Corporation.

ARTICLE I: NAME

- i. Corporation Name: BusinessFlare Academy, Inc. ("BFA").
- ii. Corporation DBA(s): The BF Academy, Inc., and BusinessFlareAcademy.org

ARTICLE II: PLACE

- i. Principal place of Business: 1175 NE 125th Street, 601, North Miami, FL 33161.
- ii. Nature of Business & Travel: The corporation officers, staff and affiliates conduct business of premises and virtually as required for the purposes of the corporation.

ARTICLE III: PURPOSE BY STATUTORY TYPE

- i. BFA is as an educational organization that instructs and trains public servants, such as local government staff, locally appointed government board members or local government elected officials, for the benefit of improving or developing their capabilities in the governmental areas of community, economic and workforce development and revitalization; and
- ii. As an educational organization, BFA provides local governments with additional instruction for their public on subjects useful to individuals and beneficial to the community that involve economic and workforce development and revitalization, including, but not limited to, educating veterans, youth, and those with barriers to labor force participation, on forms of self employment including micro-enterprise and entrepreneurial business development germane to the locale.

- i. BFA is an organization whose activities consist of conducting public discussion groups, forums, panels, lectures, or other similar programs; and
- ii. BFA is an organization that will presents a course of instruction by correspondence or through the use of television, radio or internet streaming for its marked educational,

certificate and accreditation programs in community, economic, and workforce development and revitalization known as the BusinessFlare Method.

ARTICLE IX: DISSOLUTION

- i. Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (three) of the internal revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
- ii. The original incorporator, stated above in Article VI: Section A, shall solely decide the charitable or government organization(s) that benefit from a dissolution, with the current stated expectation that they be charitable organizations that support veterans in need, including, but not limited to, assisting veteran economic self sufficiency through self employment, business development, and entrepreneurial skills training and education.

ARTICLE X: EFFECTIVE DATE

The amended and conformed articles have a retroactive effective date of January 1, 2022.
