# ARTICLES OF INCORPORATION OF MIAMI MASTERS BASKETBALL LEAGUE, INC.

#### ARTICLE I

#### <u>NAME</u>

#### 1.01 Name

The name of this corporation shall be Miami Masters Basketball League, Inc.

#### ARTICLE II

#### **DURATION**

#### 2.01 Duration

The period of duration of the corporation is perpetual.

#### ARTICLE III

#### **PURPOSE**

#### 3.01 Purpose

Miami Masters Basketball League, Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal tax code.

Miami Masters Basketball League, Inc. is a recreational adult basketball organization that promotes friendship, fitness and fellowship for its members as well as educational opportunities for our community's youth.

To maximize our impact, we may seek to collaborate with other non-profit organizations which fall under the 501(c)(3) section of the Internal Revenue Code and are operated exclusively for educational and charitable purposes.

#### **ARTICLE IV**

#### NON-PROFIT NATURE

#### 4.01 Non-profit Nature

Miami Masters Basketball League, Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Miami Masters Basketball League, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, **Miami Masters Basketball League, Inc.** shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code.

#### 4.02 Personal Liability

No officer or director of **Miami Masters Basketball League**, **Inc.** shall be personally liable for the debts or obligations of the corporation of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

#### 4.03 Dissolution

Upon termination or dissolution of **Miami Masters Basketball League**, Inc. any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of Miami Masters Basketball League, Inc. hereunder shall be selected by the discretion of a majority of the managing body of Miami Masters Basketball League, Inc. and, if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Miami Masters Basketball League, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

#### 4.04 Prohibited Distributions

No part of the net earnings, or properties of **Miami Masters Basketball League**, **Inc.**, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

#### 4.05 Restricted Activities

No substantial part of **Miami Masters Basketball League**, **Inc.**'s activities shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in nor intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, **Miami Masters Basketball League**, **Inc.** shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

#### **ARTICLE V**

#### **BOARD OF DIRECTORS**

#### 5.01 Governance

Miami Masters Basketball League, Inc. shall be governed by its board of directors, as defined in the corporation's bylaws.

#### 5.02 Directors

The number of directors and the method of selecting directors shall be fixed by the Bylaws of Miami Masters Basketball League, Inc. The initial directors shall be four (4). The names and addresses of these initial directors are as follows:
