Articles of Incorporation Of

Article 1.

The name of the corporation is Florida Phenoms 2024, Inc.

Article 2.

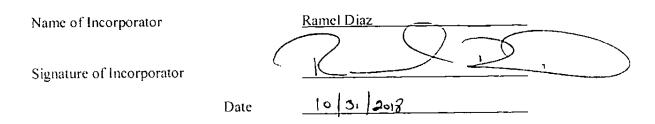
Article 9.
