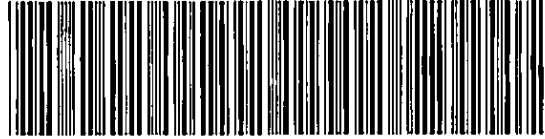

Articles of Incorporation
of
GRC Dogsports, INC.
In compliance with Chapter 617, F.S.. (Not for Profit)

Article 1: Name

The name of the corporation shall be: GRC Dogsports, Inc.

Article 2: Principal Office

Article 3: Purpose

The purpose is to provide people with the motivation to give their dogs the training they need to thrive in the world, and a healthy place to exercise their natural drives through local clubs which will offer competitive events inviting all breeds of dogs at all training levels to compete in the events, all exclusively for fostering national and international amateur sports competitions within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article 4: Activities Not in Furtherance of Exempt Purpose

No part of the net earnings of GRC Dogsports (the "corporation") shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for

public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 5: Dissolution

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article 6: Director Election

The incorporator shall appoint the initial directors and the succession of directors will be in accordance with the Bylaws.




