Board of Directors. The power of this Corporation shall be exercised, its properties controlled, and its affairs conducted by a board of Directors, consisting of not less than three (3) persons. The number of Directors of the Corporation may change from time to time pursuant to these by laws, however, that such number shall not fall below three (3) persons.
