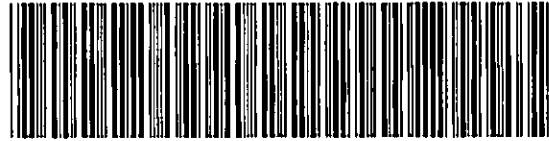

ARTICLE I NAME

The name of the corporation shall be Project Focus, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 325 S. Boulevard, Tampa, Florida 33606.

ARTICLE III PURPOSE

The corporation is organized exclusively for charitable, educational, and scientific purposes.

ARTICLE IV MEMBERS

The corporation shall not have Members.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall consist of not fewer than three nor more than fifteen members. Directors shall be elected by the Board of Directors, and shall serve at the discretion of the Board. The names and addresses of the initial Directors of the corporation are as follows:

ARTICLE VI PROHIBITED ACTIVITIES

The corporation shall not:

A. Attempt to influence legislation as a substantial part of its activities;

B. Allow any part of its net income or assets to inure to the benefit of officers, directors or members of the

corporation, or to any other individuals, except in furtherance of its charitable, educational, literary, or scientific purposes;

C. Participate to any extent in any political campaign for or against any candidate for public office; or

D. Conduct any activities not permitted to be carried on by organizations exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and its regulations as they now exist or as they may hereafter be amended.

#### **ARTICLE VII DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose.

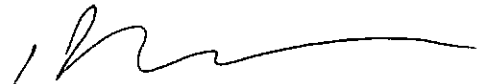
