Article III Corporate Purpose

The Corporation is established within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding
section of any future federal tax code, and shall be operated exclusively for charitable purposes in support of non-profit
Guatemalan organizations and native missionaries that give medical care and health and nutritional services and education to
indigent persons.
No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees
officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable
compensation for services rendered and to make payments and distributions in furtherance of the purpose described in
section 501(c)(3). No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or other-
wise attempting to influence legislature, and the Corporation shall not participate in, or intervene in (including the publishing
or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not
withstanding any other provisions of these articles, the Cotporation shall not carry on any other activities not permitted to be
carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the
corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section
170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
Article VIII Dissolution
Upon dissolution of the Corporation, the Board of Directors, after paying or making provision for payment of all the
liabilities of the Corporation, shall distribute all of the assets of the Corporation for one or more exempt purposes within the
meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall
be distributed to the federal government, or to a state or local government, for public purpose.
