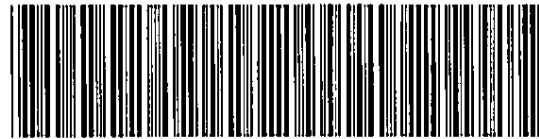

AMENDING ARTICLE III : PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED
