

#### ARTICLE III PURPOSE

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Our purpose is to provide animals in need a permanent home or to help find them a forever home. We plan on housing, feeding, providing medical care and vaccines, spaying and neutering, transporting, providing enrichment and love to these animals. We intend to use funds raised to grow and purchase more property in the future where we will have the capacity to take in more animals. We would also use the property to have fundraising and educational events as well as the opportunity for people to volunteer and get educated on the plight of these animals and veganism. Fundraising through but not limited to events, item sales, donations, sponsorship and grants will go towards the rescue and eare of the animals as well as purchasing supplies and equipment to develop and maintain the property along with putting on events, raising awareness of the sanctuary and any other matters consistent with the furtherance of this corporations ideals. When possible Live Freely Sanctuary will donate towards other 501(c)(3) organizations.

#### ARTICLE VIII ADDITIONAL PROVISIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article [#] hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon termination or dissolution of Live Freely Sanctuary, any assets lawfully available for distribution shall be distributed to one or more qualifying (Animal Rescue) organizations described in Section 501(c)(3) of the Internal Revenue Code.
