Pursuant to Section 617.1006 of the Florida Statutes, the Articles of Incorporation of EIREA ACADEMY, INC., a Florida not for profit corporation (the "Corporation"), are hereby amended as follows:

- 1. The name of the Corporation is LIFE ACADEMY, INC.
- 2. Article III of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

"ARTICLE III Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, including promoting health, wellness, and education programs in the Tampa Bay community."

3. Article IX is added to the Articles of Incorporation of the Corporation and shall read in its entirety as follows:

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principle office of the Corporation is then located, exclusively for exempt purposes within the meaning of 501(c)(3) or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes."
