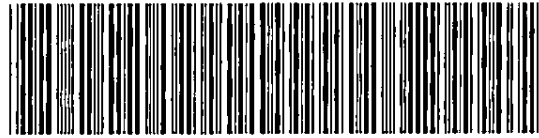

I write to dissolve a for-profit corporation and convert the organization to a non-profit organization of the same name.

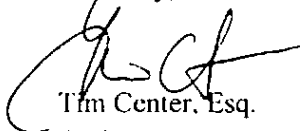

## **ARTICLES OF INCORPORATION**

### **Article I**

#### ***Name and Address***

The name of the corporation is Capital Area Community Action Agency Holdings, Inc. The principal office and mailing address of this corporation are: 309 Office Plaza Drive, Tallahassee, FL, 32301.

### **Article II**

#### ***Term of Existence***

The date when corporate existence shall commence shall be the date of the filing of these articles of incorporation by the Office of the Florida Department of State and the Corporation shall have perpetual existence thereafter.

### **Article III**

#### ***Purpose***

The Corporation is organized and shall be operated exclusively for charitable and educational purposes, within the meaning of the Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code, including, but not limited to:

- (a) Ensuring that clients served by the Capital Area Community Action Agency, Inc., are treated fairly and given the opportunity to pursue a path to prosperity through services provided; and
- (b) Developing and managing property, facilities, and venues that permit the delivery of services to low-income families be coordinated, efficient, cost-effective and successful. is The specific purpose or purposes for which the corporation is organized.

### **Article IV**

#### ***Members***

The qualification of members and the manner of admission of members shall be as specified in the by-laws of the Corporation.

**Article V**  
***Registered Office and Agent***

The street address of the registered office of the corporation is 309 Office Plaza Drive, Tallahassee, FL 32301, and the name of its registered agent is Tim Center.

**Article VI**  
***Directors***

The number of directors may be increased or decreased from the time to time and their election and appointment shall be as specified in the by-laws of the Corporation, provided that the Corporation shall always have at least three (3) directors.

**Article VII**  
***By-Laws***

The power to adopt, alter, amend, or repeal by-laws shall be vested in the Board of Directors of the Corporation.

**Article VIII**  
***Amendment***

These articles of incorporation may be amended in the manner provided by law.

**Article IX**  
***Dissolution***

Upon dissolution of the corporation, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purposes.

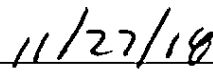
**Article X**  
**Limitations**

**Section 1. Legislative and Political Activity.** No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements in connection with) any political campaign on behalf or in opposition to any candidate for public office.

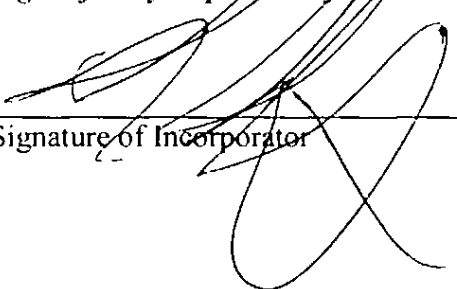

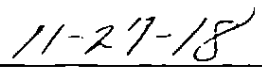
