ARTICLES OF INCORPORATION OF SOL BLAZERS LACROSSE, INC. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Sol Blazers Lacrosse, Inc.
