Article III of the Articles of Incorporation Is hereby amended to add the following:

This Corporation is a not-for-profit corporation, organized exclusively for charitable purposes as defined in

Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") or successor statute and for the purpose

of engaging in any lawful act or activity not for pecuniary profit for which non-for-profit corporations may be organized,

so far as is or may be permitted by the laws of the State of Florida and Section 501(c)(3) of the Code, including, for such

purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the

Code, or the corresponding provisions of any future United States Internal Revenue law.

New Article IX is added to the Articles of Incorporation as follows:

ARTICLE IX DISSOLUTION

Upon dissolution or winding up of this Corporation, its net assets remaining after payment, or provision for payment,

of all debts and liabilities of the Corporation shall be distributed to one or more not-for-profit fund, foundation, or

corporation which is organized and operated exclusively for charitable purposes and which has established its

tax-exempt status under Section 501(c)(3) of the Code (or the corresponding provision of any future United States

Internal Revenue law).
