The below amendments have been adopted by the Board of Directors and by the members of this corporation at a duly called meeting on the 2nd day of June, 2024. The number of votes cast by the members was sufficient for approval.

Pursuant to the Florida Not for Profit Corporation Act Chapter 617, Florida Statutes (the "Act"), as amended from time to time, the following are adopted as the Articles of Incorporation of the Corporation.
