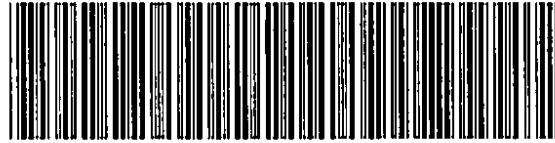

**ARTICLE I: NAME:
TEAM EXCELLENCE INTERNATIONAL, INC.**

ARTICLE II. PRINCIPAL ADDRESS

ARTICLE III. THE PURPOSE

a. to operate in a manner supportive of community, charitable and educational efforts consistent with criteria as an exempt organization under section 501(c)3 of the Internal Revenue Service Code of 1986, as amended or for corresponding purpose of any future Internal Revenue laws including laws for private foundations/or organizations.

b. to partner with corporations and businesses to obtain funding to be used to assist qualified students with scholarships, housing, books and other educational needs.
