The following is placed at the beginning of article III of the Not for Profit Articles of Incorporation: This corporation is founded exclusively for religious charitable purposes within the meaning of the IRS Code Sec 501(c)(3); namely:

To establish and maintain a church for worship according to the tenets of Pentecostal Evangelical Christianity and there to provide worship services, spiritual guidance, community building, religious education, spiritual events, celebrations and other activities. This corporation is will carry out all its activities according to Pentecostal Evangelical Christian doctrines and traditions as understood by the church's spiritual leader Pastor Rubens Barbosa Bomfim . The church will promote the awareness of the Word of God. It will serve as a sign of the grace of God and of the God of grace, and that through His Son Jesus Christ, He offers to all people, at all times and in all places, eternal salvation --the physical signs of which

--are that people are transformed by the Holy Spirit, that Divine Love is materialized in blessings, and that those inspired are called to proclaim God's love everywhere. The church will be a welcoming spiritual environment for those who have no church. It will strive to live and preach the entire "Good News", reaching out, encouraging and caring fully for those people who are targets of God's love. It will prepare people for redemption and teach the importance of serving God, serving the community and proclaiming God's Kingdom. This corporation is empowered to purchase any items, products, constructions, real property, services or resources and to pay compensation for work or services provided in order to establish and operate the church and provide a parsonage for the Pastor and his family. It is empowered to carry out any actions that are seen by the pastor or the directors as being in furtherance of the corporation's goals or conducive to the betterment of humanity. The pastor has been accepted by the community in keeping with the practices and traditions of Pentecostal Evangelical Christianity, and he is the final authority in all matters of Christian faith, including the sole prerogative to determine which issues relate to Christian faith and thus require his decision.

Upon the dissolution of this corporation, all its remaining assets --after clearing all debts and liabilities-- shall be distributed by the directors to one or more organizations with similar exempt purposes recognized under section 501(c) (3) of the IRS Code.
