# ARTICLES OF INCORPORATION OF TOWER PALMS HOMEOWNERS ASSOCIATION, INC.

The undersigned subscriber to these Articles of Incorporation, for the purpose of forming a corporation not-for-profit, pursuant to Chapter 617 of the Florida Statutes, does hereby adopt the following Articles of Incorporation for such corporation:

### ARTICLE I. NAME

The name of the corporation is Tower Palms Homeowners Association, Inc., hereinafter called the "Association."

### ARTICLE II. PRINCIPAL OFFICE

The principal office of the Association is located at 2621 Brookside Bluff Loop, Lakeland, Florida 33813. The Board of Directors of the Association may change the location of the principal office of said Association from time to time.

#### ARTICLE III. REGISTERED AGENT

William E. Tower, Jr., whose address is 2621 Brookside Bluff Loop, Lakeland, Florida 33813, is hereby appointed the initial registered agent of this Association.

### ARTICLE IV. PURPOSE AND POWERS OF ASSOCIATION

Tower Palms, LLC, a Florida limited liability company ("Developer"), has developed a residential subdivision in Polk County, Florida, known as Tower Palms, the plat of which will be recorded in the Public records of Polk County, Florida, and which will be referred to hereinafter as the "Subdivision". The Subdivision is subject to the terms of that certain Declaration of Covenants, Restrictions, Limitations and Conditions to be recorded in the public records of Polk County, Florida, which will refer to the Association and which will be referred to herein collectively as the "Declaration". This Association does not contemplate pecuniary gain or profit to its members and is formed as the Association described and referred to in the Declaration, shall have the power and responsibility to perform the maintenance and other obligations and responsibilities specified in the Declaration, and shall have the power and authority to enforce the terms, restrictions and other provisions of the Declaration. The Association shall also have such other authority as may be necessary for the purpose of promoting the health, safety, and general welfare of the residents, and of the owners of lots in the Subdivision who are members of the Association.

In furtherance of such purposes, the Association shall have the power to:

(a) Exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the Declaration, as the same may be amended from time to time as therein provided, the terms of which Declaration are incorporated herein by reference;

- (b) Fix, levy, collect, and enforce payment by any lawful means of all charges and assessments pursuant to the terms of the Declaration and the Bylaws of the Association; and pay all expenses in connection therewith, and all office and other expenses incidental to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied on or imposed against the property of the Association;
- (c) Acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection wit the affairs of the Association;
- (d) Borrow money, and with the assent of two-thirds (2/3) of each class of members, mortgage, pledge, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (e) Participate in mergers and consolidations with other nonprofit corporations organized for the same purposes, provided that any such merger or consolidation shall have the assent of two-thirds (2/3) of each class of the members:
- (f) Operate and maintain common property, specifically including, without limitation, the surface water management system, as permitted by South Florida Water management District, including all lakes, retention areas, water management areas, pipes, ditches, culverts, structures and related appurtenances; and
- (g) Have and to exercise any and all powers, rights and privileges that a nonprofit corporation organized under Chapter 617 of the Florida Statues by law may now or hereafter have or exercise, as well as all other express and implied powers of corporations not-for-profit; and
- (h) Adopt, modify and enforce reasonable rules and regulations regarding the use of the common property and Lots within the Subdivision in furtherance of the terms of the Declaration and the Bylaws of the Association.

The Association shall be conducted as a nonprofit organization for the benefit of its members. The Association is organized and shall be operated exclusively for the purposes set forth above. The activities of the Association will be financed by assessments against members as provided in the Declaration and in accordance with the Bylaws and no part of any net earnings of the Association will inure to the benefit of any member.

### ARTICLE V. MEMBERS

Every person or entity who is a record owner of a fee or undivided fee interest in any lot (as defined in the Declaration and referred to herein as "Lot") in the Subdivision shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of a Lot. Voting of Members at any meeting of the Members of the Association shall be in accordance with the provisions of the Bylaws.

### ARTICLE VI. DURATION

The period of duration of the Association shall be perpetual, unless sooner dissolved pursuant to provisions of Florida Statutes 617, as amended.

### ARTICLE XII. DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by no less than two-thirds (2/3) of the members. Upon dissolution of the Association, other than incident to merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposed similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed, and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.
