ABOEC 20 PM 4: 50 The undersigned hereby presents these Articles of Incorporation for the formation of a Florida not for profit corporation pursuant to the Florida Not For Profit Corporation, Ac provided in Chapter 617 of the Florida Statutes.

ARTICLE I. NAME

The complete legal name of this Corporation shall be THE BIG FAT TIP, INC.

ARTICLE II. PRINCIPAL OFFICE AND/OR MAILING ADDRESS

The address of the principal office and mailing address of the Corporation is 4747 Highlands Place Drive, Lakeland, Florida 33813.

ARTICLE III. **DURATION**

The term of existence of the Corporation is perpetual. The corporate existence shall commence with the filing of these Articles of Incorporation.
