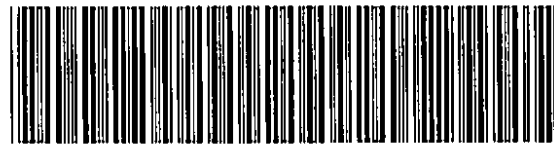

In compliance with the requirements of Chapter 617, F.S., and for the purposes of forming a not for profit business corporation in Florida, the undersigned desire to form a corporation according to the following Articles of Incorporation.

Corporate Name

1. The name of the corporation is United 4 Justice 386, Inc..

Purpose

2. To support victims if police violence and mass incarceration, and their families as well as educating citizens in obtaining justice in their communities. Building support for strong families, communities and institutions that work for all people.

Duration

3. The duration of the Corporation is perpetual.

9. This document will become effective on the date of filing.




