We apologize for this late or re-filing, however, we were unaware that the current status was inactive and the last event of administration dissolution for annual report dated 9/21/01 had occurred. We were only made aware of the current situation upon filing for the workmen's compensation exemption for our officers. After review of our records, we find that the state department cancelled our filing check #13240 dated 9/10/01 on 9/17/01 (copy enclosed), four days before the administration dissolution.
