These Articles of Amendment to the Amended and Restated Articles of Incorporation of Center for Corporate and Family Health, Inc., a Florida not for profit corporation (the "Corporation"), are adopted and filed pursuant to the provisions of the Corporation's Amended and Restated Articles of Incorporation, Bylaws, and Sections 617.1001, 617.1002(b) and 617.1006, Florida Statutes, having been duly authorized, approved and adopted by unanimous vote of the Board of Directors and Members of the Corporation at a meeting properly noticed and held on March 3, 2000, and upon filing with the Florida Department of State, shall be effective as of March 4, 2000.

**ARTICLE I**
