

### SUBSTANTIAL REWORDING OF ARTICLES SEE CURRENT ARTICLES FOR CURRENT TEXT.

These are the Amended and Restated Articles of Incorporation of Somerset at the Reef Condominium Association, Inc., originally filed with the Florida Department of State on January 16, 1987, under Charter number N18787. Amendments included herein have been adopted pursuant to Chapter 617, Florida Statutes.

For historical reference, the street address of the initial principal office and initial mailing address of the Corporation was 3215 West Gulf Drive, Sanibel, Florida, 33957. The name and address of the initial incorporators at the time of incorporation, were John Naumann, 1149 Periwinkle Way, Sanibel, Florida, 33957, William J. Simmonds, 1149 Periwinkle Way, Sanibel, Florida, 33957, and Jeffrey J. Milton, 1120 Connecticut Avenue, Washington, D.C., 20036. The street address of the initial registered office was 1149 Periwinkle Way, Sanibel, Florida, 33957, and the name of the initial registered agent was John Naumann.

The name and address of the current registered office is Suitor, Middleton, Cox & Associates, 15751 San Carlos Boulevard, Fort Myers, Florida, 33908. The Board of Directors may, from time to time, change the principal office, the mailing address of the corporation, the registered office and the registered agent, in the manner provided by law.

#### **ARTICLE I**

The name of this corporation is SOMERSET AT THE REEF CONDOMINIUM ASSOCIATION, INC.

#### **ARTICLE II**

The purpose for which this corporation is organized is to act, pursuant to the Florida Condominium Act, as the entity operating the condominium association located in the City of Sanibel, County of Lee, Florida, known as Somerset at the Reef Condominium.

#### ARTICLE III

The corporation shall have all the powers of a corporation organized under Chapter 617 of the Florida statutes and under the Florida Condominium Act, Chapter 718 of the Florida statutes as amended from time to time hereafter. The existence of the corporation shall be perpetual. The only members of the corporation shall be the record Owners of Units, as defined in the Condominium Declaration of the Association, voting as described in said Declaration.

#### ARTICLE IV

The affairs of the corporation shall be managed by a Board of Directors consisting of not fewer than three (3) and not more than seven (7) members, as determined in the corporation's bylaws. The method of election of the Directors and officers of the corporation shall be set forth in the corporation's bylaws.

#### ARTICLE V

Amendments to these Articles of Incorporation may be proposed by either the Board of Directors or by twenty percent (20%) of the voting interests of the membership and may be considered at any meeting of the Owners, regular or special, at which due notice has been given according to the Bylaws. Amendments must be approved by a vote of two-thirds of the voting interests of the membership.

These Amended and Restated Articles of Incorporation were duly adopted by the required percentage of voting interests.
